### **UNITEDSEATS Solid Waste Policy**

Therefore, it is our goal to reduce 100% of the solid waste destined for landfill disposal resulting from the fabrication and assembly of our products. Through improvements in material efficiency, reductions in scrap rates, and landfill diversion strategies such as material reuse, recycling and other diversion strategies, UnitedSeats is committed to working towards achievement of this goal.

### At present all of the below materials are recycled on or off site:

- Re-used as packing or shredded as packing material; Cardboard

Paper - Shredded and re-used as packing material;

Pallets Plastic Foam Steel - Re-used by ourselves;

- Sent for recycling;

- Re-used as packing material;

- Collected by scrap merchants for recycling.
